The **Millstream Career Exploration (MCE)** program is a 1-year long course. Students in the **MCE** program will participate in a three period block each day where they will explore one career cluster every twelve weeks. There will be different explorations throughout the year. In addition to exploring career-technical areas, the **MCE** students will receive computer and employability skills, as well as a comprehensive **Career Assessment\*** that will assist them in formulating their own career plans.

Students who successfully complete their rotations are encouraged to apply to enter the 2-year (junior and senior years) career-technical education program that best conforms to their individual interests and abilities.
